# 2023 Winter Taxes are due on February 29, 2024

February 15, 2024 is the State mandated due date for Winter 2023 property taxes. The State has offered a provision to allow local units of government to collect until the last day of February without penalty or interest due from the taxpayer. Wayne Township has always chosen to exercise that option for the benefit of our taxpayers.

Between September 15, 2023 and February 29, 2024, delinquent Summer 2023 taxes are payable at the Township Treasurer's office. There is a 1% per month fee added to the Summer 2023 taxes. You must include the late fee with your payment! After February 29, 2024, additional interest and fees apply and the tax must be paid to the Cass County Treasurer.

# PAYMENT INFORMATION

- Enclose a copy of the tax bill or the perforated top portion of the bill
- Include the tax parcel ID number to ensure proper credit
- If paying multiple parcels with one check, identify how much should be credited to each parcel ID
- If the tax bill is underpaid, you may be subject to interest charges
- Wayne Township is NOW able to accept payment by credit card- go to <a href="www.WayneTwpMl.org">www.WayneTwpMl.org</a> – select "Taxes": and then the payment button

## **Postmarks are Precarious**

Placing your tax payment in a USPS mailbox on the last day to accept taxes DOES NOT guarantee that it will be postmarked that day. If you are mailing in your payment, I strongly suggest that you mail **no later than 5 days** before the deadline.

# WHAT'S AN AMBULANCE ASSESSMENTT?

Wayne Township has been extremely fortunate to have had the services of PrideCare Ambulance for more than 16 years. During this time PrideCare did not charge the Township to keep an ambulance stationed within a nearby distance for emergency calls. But ambulance service has changed. Today's ambulance, instead of the back of a hearse, is now a mini-hospital. Instead of one person to drive the vehicle, each ambulance has a crew of two - an EMT and a paramedic. Ambulance service is an expensive business, and PrideCare could not keep up with the mounting costs. They have pulled out of the entire Michigan marketplace.

The multiple-municipality consortium that contracted with PrideCare has worked very extensively to find another service provider for ambulance care. At this point, all agreements are for very short periods of time as the consortium representatives continue to strive to obtain excellent emergency service for their communities. Meanwhile, any company that the municipalities contract with requires a substantial fee just to have an ambulance on-call. In order for Wayne Township to fund this fee, an ambulance assessment district, first created in 1998, now needs to levy a \$50 fee assessment for each improved parcel in the Township. For the past many years the assessment has been normally set at \$0.00.

If you use the ambulance service you and your insurance company will still be billed for your use. This assessment does not pay for your ride – it only makes it possible to have an ambulance available for that ride.

As with so many governmental services, you are paying for a service that you might never use. If this is the case, just consider yourself very fortunate.
